

# **Blaine County, Idaho GIS Data Disclaimer**

## **1. Limitations**

Requester seeks access to the data described in the attached request. The County makes no warranty, expressed or implied, concerning the data's content accuracy, currency or completeness, or concerning the results to be obtained from queries or the use of the data. **ALL DATA IS EXPRESSLY PROVIDED "AS IS" AND "WITH ALL FAULTS"**. The County makes no warranty of fitness for a particular purpose, and no representation as to the quality of any data. Users of data are responsible for ensuring the accuracy, currency, and other qualities of all products (including maps, reports, displays and analysis) produced from or in connection with County's GIS data. No employee or agent of the County is authorized to waive or modify this paragraph. If a user informs others that a product is based upon County's data, the County specifically requests and directs that the user also disclose the limitations contained in this paragraph and in paragraph 4.

## **2. Data Interpretation**

County data is developed and maintained solely for County business functions, and use or interpretations of data by the Requester or others is solely their responsibility. The County does not provide data interpretation services.

## **3. Spatial Accuracy**

Map data can be plotted or represented at various scales other than the original source of the data. The Requester is responsible for adhering to industry standard mapping practices that specify that data used in a map or analysis, separately or in combination with other data, will be produced at the largest scale common to all datasets.

## **4. No County Liability**

County shall not be liable to the Requester (or transferees or vendees of Requester) for damages of any kind, including lost profits, lost savings, or any other incidental or consequential damages relating to the providing of the data or the use of it. The Requester shall have no remedy at law or equity against the County in the case the data provided is inaccurate, incomplete, or otherwise defective in any way. In the event the data obtained from the County is modified by the Requester, a third party, or any person or entity obtaining the requested data, Requester agrees that it proceeds at its own risk and County shall not be liable for any claims arising out of such modifications. In addition, Requester agrees to defend and indemnify County for any claims arising out of such modifications.

## **5. Secondary Data Dissemination**

Requesters may not secondarily disseminate (give County data to other entities) without prior written permission from the County.

## 6. Project Data

Requesters are encouraged to supply their project data back to the County for use by the County.

## 7. State Law
